- 1) Cannabis Control Commission Guidelines Discussed the changes to the community host agreements and also the requirements for creating a criterion for accepting future agreements, web site posting requirements, paper packet requirements, and the annual approval of any Host agreements going forward. Also discussed the implications of all the changes for small towns such as ours. Valentine Reid is going to write letter for the hearing on the regulations, Jared bellows is going to reach out to the owner of the one actively pursuing a cannabis project and discuss the changes and their feelings on it, will report back. The administrator is going to find out from Massachusetts Municipal Association if anyone is pursuing any legal actions with this.
- 2) Long Bridge- Work will start on the 28<sup>th</sup> of August to install the platform below the bridge.
- 3) Massachusetts Certified Purchasing Official Class- Discussed purchasing and Administrator had asked Highway Superintendent if he was interested, he was not ready to do classes just yet, on a motion by Jared Bellows and second by Valentine Reid the administrator will apply for the free classes.

4) Mass Energy Insight user request- Administrator asked to do three user accounts, one for FRCOG, one for the administrator, and one for selectboard. On a motion by Valentine Reid and second by Bill Harker passed unanimously.
