To the members of the Charlemont Planning Board,

I have a scheduled meeting with the planning board on Thursday June 3, 2021 to update the permits for Hyytinen Hollow. Also, a walk though of my properties on May 20<sup>th</sup>.

- First, I would like to be able to incorporate all three pieces my properties; 7 Tea Street Ext, Tea Street Ext (the riverfront land), 15 Street Ext, (part of 7 Tea Street Ext property) and newly acquired 23 Tea Street Ext as part of my business plan known as Hyytinen Hollow.
- I am in need to update my permit to allow for addition parking spaces on 7 Tea Street Ext, **PARCEL 4** from the existing 9-14 to now allow up to 30 cars plus employees' cars.

On Tea Street Ext. the riverfront land, **PARCEL 8-1** I would like to allow up to 25 cars to park. The parking area on this land is at least 10' to 15' above the river level and approximately 100' from the river.

On my newly purchased property, 23 Tea Street Ext. PARCEL 3 I would like a permit to park up from 28 to 30 more vehicles.

Combining these hopefully permitted parking spaces Hyytinen Hollow will have parking ability for at least 80 vehicles.

• I also would like to apply for a permit to offer shuttling of customers for Hyytinen Hollow from 7 Tea Street Ext to the Zoar Picnic Area.

On weekends we offer chartered school buses to transport our customers, allowing patrons to park their personal vehicles here in one of our designated lots. This also means less vehicles parking up at the Zoar Picnic Area and at Shunpike Rest Area alleviating some of the congestion. Our customers then exit the river here at Hyytinen Hollow.

• Our next permit request is for signage down on the river land area. These are small banners giving persons on the river notice that it is where they

should exit the river, whether to return their tubes back to Hyytinen Hollow or to stop at Sue-Per Dogs for a hotdog or other beverage. We have two banners possible 2 foot by 6 foot and two feather flags to catch their attention. These banners and feather flags are only on the river during the season of operation. Their location is noted on the MAPS with a RED CIRCLE on PARCEL 8-1

- I am also asking for a permit to allow egress from the river onto Hyytinen Hollow property. This could be for use by any person on the Deerfield River needing or wanting to exit the river, for wanting a hotdog, for use of the porta-potties, or the dumpster, for a safety reason or any other reason they feel they have.
- I am asking for a permit to allow family and or friends of family to occasionally camp down on my river land. Not as a campground but as a place for friends to have a quiet spot to enjoy for a day or two. The location is at the west end of my riverfront property marked with this symbol.
- Other items mentioned during the previous meeting you requested our hours of operation and a brochure of our business. One is enclosed.

We try to open both Hyytinen Hollow and Sue-Per Dogs on Memorial Day weekend, weather permitting. We then open for the season on the second weekend of June. The first weekend in June being reserved for Mass Free Fishing weekend. There is no scheduled water release.

Our hours of Operation:

Monday and Tuesday: Closed. Unless it is a holiday.

Wednesday: 11 until 5pm

Thursday and Friday: 11 until 5pm Saturday and Sunday: 10 until 6pm.

Sue-Per Dogs is open Saturday and Sunday, and the 4<sup>th</sup> of July. 11 until 6. We close for the season on Labor Day.

I would like to now give you a very tentative plan regarding 23 Tea Street Ext. PARCEL 3

This year we plan to clean the land from debris, and a remove few scraggly trees.

Button up the house to make it safe from intruders and hopefully preserve what parts of it we can.


Tear down the bigger of the two back buildings. And hopefully re-roof the other for storage.


As for the house, it is to be determined if any of it is salvageable. If part of it is, we are thinking in the future, we would possibly like to renovate it into possible 2 rooms to rent with a bathroom/shower house housed in the middle between the two rooms. This will also be accessible for persons renting proposed cabins.

We are thinking on the lines of having 6 to 10, 10'x10' cabins for seasonal rentals. These would be along the western and back side of the property.













Location grouping of 3 flags. At path to Hyytinen Hollow and Sue-Per Dogs.




