#### NOTICE FROM ASSESSOR'S OFFICE

#### ON INCREASES TO PROPERTY TAX EXEMPTIONS AND

#### DECREASE TO MINIMUM PERSONAL PROPETY EXEMPTION

At the May 30<sup>th</sup> Annual Town Meeting, three local option Warrant Articles were approved which relate to property tax exemptions and the taxation of personal property and shall take effect beginning in Fiscal Year 2024.


The first approved an increase to the income and asset allowances for the 41C Senior property tax exemption application. Recognizing that the current limits are very low and difficult to meet, this raises the annual income seniors are allowed to make as well as the value of their whole estate (assets), to be more in line with the current economy.

The second approved an annual increase in the amount of the 17C ½ exemption for seniors, surviving spouses, or surviving minors, by the percent increase of the Consumer Price Index (CPI) for the previous year. Again, because the current exemption amount is very low this increases the exemption by the annual CPI, cumulatively.

The last decreases the minimum personal property value exemption to \$1,000 (property valued at less than \$1,000 is exempted from taxation). This increases the revenue to the Town from personal property taxes by lowering the minimum personal property exemption value from the current \$2,500 to \$1,000.

These local options are all adopted/amended per the provisions of General Laws Chapter 59, Section 5. # Office of Tree warden Annual Report

The Tree Warden is governed by the Massachusetts Public Shade Tree Law and conducts assessment of trees for potential hazards to public safety along town owned public byways. The scope of the job is broad and includes responsibility for all community trees – on streets and roads, parks, and other town owned property.

In 2022, approximately 50 hazard trees were removed/safety pruned by direction (and by town approval) of the Office of Tree Warden from North River Road, East Oxbow Road, Burnt Hill Road, Legate Hill Road, and Warner Hill Road. Simultaneously, hazard trees over utility lines were identified and brought to National Grids attention. As a result, 20 trees town-wide have been removed by National Grid contractors and this project is still on going in 2023. We have seen a noticeable improvement in damage and downed trees during storms.

Charlemont's Wood Policy states in part: If the wood can be used as firewood, the property abutter has the right of first refusal. All or part of the wood may be left as requested. This is providing that if the wood were left on site, it would not create any safety hazard to the public. The wood is left in large sections that would need to be cut and split by the recipient for use. If the abutter does not want the wood, it becomes available for neighbors and other residents.
